



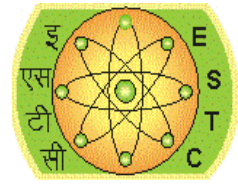

7. **(a)** A demand draft/ CBS Cheque amounting Rs 8000/- (Rupees eight thousand only) in the name of the Principal Director, Electronics Service & Training Centre payable at Ramnagar (Nainital) towards lump-sum amount of Earnest Money (Refundable) must be submitted at Electronics Service & Training Centre, Ramnagar by 27 Feb. 2017 before 5.00 PM. The same will be forfeited, if the execution of the order is not made in time. The offers without Earnest Money Deposit will be considered as unresponsive and will be rejected.
